Project 2027 100-Day Legislative Agenda

This schedule translates the Project 2027 priority repairs into a concrete legislative calendar for the first 100 days of the next pro-democracy Congress. It is designed to travel with the resources highlighted on <u>officials.html</u> and the Project 2027 overview page.

Timeline at a Glance

The timeline favors quick floor wins, visible oversight, and sequencing that keeps the Five Guarantees in front of the public every week.

- Day 1–10 Introduce and fast-track floor action on the Emergency Rule of Law Restoration Act and the DOJ & Civil Service Integrity Act. Hold Judiciary and Oversight hearings on presidential immunity claims, OLC policy, and purged inspectors general.
- Day 11–25 Mark up the Federal Officer Accountability & Due Process Act and the Free Speech &
 Anti-Retaliation Act. Secure bipartisan statements from law enforcement, academic, and press-freedom
 witnesses. Publish public contact logs between the White House and DOJ as an early transparency
 deliverable.
- **Day 26–45** Move the Democracy Defense & Fair Representation Act through House Administration and Senate Rules. Coordinate state-level testimony on current mid-decade map attempts. Introduce enabling grants for compliant independent commissions.
- Day 46–70 Take up the Secure Elections & Voter Access Act on the floor with a bipartisan registrar
 roundtable. Release joint DHS/EAC guidance on audit readiness and vote-by-mail tracking before final
 passage.
- **Day 71–90** Move the Clean Money & Ethics Enforcement Act. Pair the floor debate with FEC modernization testimony, and publish draft regulations for real-time disclosure and foreign-ownership attestation.
- Day 91–100 Conference any outstanding differences, launch the oversight dashboards mandated by
 the earlier bills, and schedule follow-up hearings on compliance readiness across DOJ, OPM, EAC, and
 the new FEC structure.

Priority Bills Snapshot

- Emergency Rule of Law Restoration Act Clarifies that no federal official is above criminal law, removes "official act" shields for election and civil-rights crimes, tolls statutes of limitation during service, and sets expedited three-judge review.
- DOJ & Civil Service Integrity Act Blocks Schedule F–style purges, limits White House interference to AG/White House Counsel with public contact logs, publishes final OLC opinions, protects independent special counsel budgets, and guarantees career-led succession.

- Federal Officer Accountability & Due Process Act Requires visible identification and body cameras
 for federal deployments, documents command approvals, bans off-book detentions, and guarantees 24hour probable-cause hearings with automatic inspector review.
- Free Speech & Anti-Retaliation Act Prohibits weaponization of federal power against journalists, academic institutions, civic organizations, and civil servants; codifies a reporter's privilege with narrow national-security exceptions.
- Democracy Defense & Fair Representation Act Establishes national anti-gerrymandering standards, limits remaps to once per decade absent court order, funds compliant independent commissions, and grants fast-track standing for voters to challenge unlawful maps.
- Secure Elections & Voter Access Act Requires voter-verifiable paper ballots, risk-limiting audits, minimum early-voting and vote-by-mail standards, and funds cybersecurity, staffing, and equipment upgrades for local election offices.
- Clean Money & Ethics Enforcement Act Modernizes the FEC with a nonpartisan tiebreaker, mandates real-time donor and beneficial-owner disclosure, bans foreign-influenced corporate spending, and strengthens Hatch Act and emoluments enforcement.

Committee Sequencing & Lead Sponsors

- Emergency Rule of Law Restoration Act House & Senate Judiciary as primary; coordinate with House Oversight for follow-up on immunity hearings. Pair former prosecutors and constitutional lawyers as bipartisan co-sponsors.
- DOJ & Civil Service Integrity Act House Oversight & Accountability and Senate Homeland Security & Governmental Affairs. Loop in Intel Committees for whistleblower protection briefings.
- Federal Officer Accountability & Due Process Act Homeland Security panels with Judiciary crime and civil-rights subcommittees. Engage sheriffs and federal law-enforcement associations as validators.
- Free Speech & Anti-Retaliation Act House Energy & Commerce (communications) and Senate Commerce; cross-referral to Education & Labor for academic protections. Align with the Press Freedom Caucus.
- Democracy Defense & Fair Representation Act House Administration and Senate Rules. Coordinate with state legislative leaders adopting independent commissions.
- Secure Elections & Voter Access Act House Administration (elections subcommittee) and Senate Rules; joint hearings with Homeland Security on cyber resilience. Include bipartisan local election officials as witnesses.
- Clean Money & Ethics Enforcement Act House Administration (campaign finance) and Senate Rules with Banking as consultative partner on beneficial-ownership standards.

Parallel Oversight & Implementation

- Launch "Integrity Week" hearings in Weeks 1–2 on presidential immunity doctrine, politicized prosecutions, and unauthorized federal deployments.
- Reconstitute Inspectors General: nominate replacements for purged watchdogs, require public dashboards of outstanding recommendations, and direct GAO to certify interim compliance.
- Establish cross-agency implementation task forces covering election security, civil-service retaliation, judicial ethics enforcement, and foreign influence tracking.
- Publish monthly scorecards detailing bill introduction, markup, floor passage, and implementation checkpoints to keep voters informed on progress toward the Five Guarantees.

Messaging Notes

- Anchor every press availability in the Five Guarantees, then connect that week's floor action or oversight hearing to one guarantee.
- Use a consistent call to action: "Authoritarian tactics are already here. Project 2027 passes seven bills in 100 days and restores the rule of law."
- Encourage members to promote the supporter badge set and pledge so voters can quickly see who is committed to the 100-day deliverables.
