# **Project 2027 Congressional Packet**

## **Emergency Repairs for the First 100 Days**

The United States is operating under authoritarian tactics: presidents claiming immunity from criminal law, masked agents detaining civilians without identification, civil servants threatened with lovalty purges, and critics punished for speech. Project 2027 gives lawmakers a day-one agenda to reverse the damage before it becomes permanent.

#### The Five Guarantees

- Accountability The law applies to everyone, presidents included.
- Fair Elections Every vote is counted and weighted equally.
- Clean Money Dark money is exposed and foreign influence is blocked.
- Ethical Courts Judges follow enforceable ethics and recusal rules.
- Professional Government Public service depends on merit, not loyalty tests.

### Priority Legislation — File Immediately

- 1. **Emergency Rule of Law Restoration Act** Clarifies criminal liability for federal officers, strips "official act" shields for election crimes and civil-rights abuses, tolls limitations periods, and creates expedited three-judge review with direct Supreme Court appeal.
- 2. **DOJ & Civil Service Integrity Act** Blocks Schedule F–style reclassification, codifies whistleblower and IG protections, limits White House case contact to the AG and White House Counsel with public logs, and protects independent special counsel budgets.
- 3. **Federal Officer Accountability & Due Process Act** Requires identification and body cameras for federal deployments in civilian spaces, documents chain-of-command approvals, bans off-book detentions, and guarantees 24-hour probable-cause hearings with automatic inspector review when force is used.
- 4. Free Speech & Anti-Retaliation Act Prohibits retaliatory investigations or funding cuts aimed at journalists, academics, or civil servants exercising lawful speech; codifies a reporter's privilege with tight national-security exceptions.
- 5. **Democracy Defense & Fair Representation Act** Establishes national anti-gerrymandering standards, limits remaps to once per decade absent court order, incentivizes independent commissions, and provides fast-track federal court relief for voters.
- 6. **Secure Elections & Voter Access Act** Requires voter-verifiable paper ballots, risk-limiting audits, minimum early voting, accessible vote-by-mail, and funds cybersecurity and election staff capacity.
- 7. **Clean Money & Ethics Enforcement Act** Modernizes the FEC with a nonpartisan tiebreaker, mandates real-time donor and beneficial-owner disclosure, bans foreign-influenced corporate spending, and strengthens Hatch Act/emoluments enforcement.

### **Oversight & Implementation Notes**

- Launch oversight hearings within two weeks on presidential immunity claims, politicized prosecutions, unauthorized deployments, and dark-money networks.
- Pair each bill with a detailed implementation memo for committees of jurisdiction; maintain singlesubject focus and plain-language summaries for voters.
- Require agencies to publish execution dashboards so constituents can track progress without spin.

#### **Why Urgency Matters**

Authoritarian tactics harden with time. Passing this agenda in the first 100 days re-establishes the rule of law, protects civil servants, and restores confidence that democracy can still deliver. Waiting risks entrenching impunity beyond reach.
