

Project 2027 Media Briefing

Five Guarantees. Seven Bills. One Hundred Days.

Project 2027 exists because authoritarian tactics are already visible: courts granting presidents immunity, masked agents detaining civilians without identification, civil servants threatened with loyalty purges; journalists, federal employees, and universities coerced or punished for speech, and dark money flooding elections. This briefing equips reporters with framing, facts, and follow-up questions.

The Five Guarantees

- Accountability — The law applies to everyone, presidents included.
- Fair Elections — Every vote is counted and weighted equally.
- Clean Money — Dark money is exposed and foreign influence is blocked.
- Ethical Courts — Judges follow enforceable ethics and recusal rules.
- Professional Government — Public service depends on merit, not loyalty tests.

Priority Bills

1. **Emergency Rule of Law Restoration Act** — Ends “official act” immunity for criminal conduct and fast-tracks court review.
2. **DOJ & Civil Service Integrity Act** — Blocks Schedule F–style purges, protects whistleblowers, and publishes final OLC opinions.
3. **Federal Officer Accountability & Due Process Act** — Requires visible identification, body cameras, and 24-hour probable-cause hearings.
4. **Free Speech & Anti-Retaliation Act** — Bars federal retaliation against journalists, academics, and civil servants.
5. **Democracy Defense & Fair Representation Act** — Outlaws partisan gerrymanders and funds compliant independent commissions.
6. **Secure Elections & Voter Access Act** — Guarantees paper ballots, audits, early voting, and accessible vote-by-mail.
7. **Clean Money & Ethics Enforcement Act** — Modernizes the FEC, mandates donor transparency, and bans foreign-influenced spending.



Story Hooks & Follow-Up Questions

- **Presidential immunity rulings:** Ask candidates whether they support the Emergency Rule of Law Restoration Act.
- **Masked federal deployments:** Press officials on whether they will back identification and due-process requirements.
- **Schedule F loyalty purges:** Demand commitments on reinstating merit protections and whistleblower safeguards.
- **Retaliation against media, academia and civil servants:** Probe whether candidates support statutory penalties for weaponized investigations or governmental coercion.
- **Dark money and foreign influence:** Request on-the-record positions on real-time donor disclosure and foreign ownership thresholds.

Media Guidance

- Cover Project 2027 as an emergency repair checklist, not a partisan wishlist.
- Track who signs the pledge, who files the bills, and who blocks them.
- Use the 100-day timeline as a standing benchmark in interviews, editorials, and debate questions.
